

## INVITATION TO BID ITBD-2022-02 (2nd Bidding)

1. OFBank invites interest buyers, individuals, partnerships and/or corporation for the sale of various unserviceable properties on a "As-is Where-is" basis indicated below:

- 2. No bid shall be lower than the said floor price.
- Upon payment of a non-refundable Bid Fee of Five Hundred Pesos (Php500.00), interested bidders may get the bid documents at the Land Bank of the Philippines (LBP)
   Manolo Fortich Branch, Sayre National Highway, Barangay Tankulan, Poblacion, Manolo Fortich, Bukidnon or you may download it at the OFBank website, view and inspect the said items at LBP Manolo Fortich Branch during office hours (08:00 AM 05:00 PM) from November 10 to 16, 2022.
- 4. Sealed bids will be received at LBP Manolo Fortich Branch on or before 12:00 noon of November 17, 2022 (Thursday). The bidder shall enclose in a sealed envelope the following:
  - a. Fully accomplished Bid Form (see Annex "A").
  - b. Bid Security in the amount of not less than ten percent (10%) of the total bid price in the form of cash or manager's check issued by a reputable bank payable to "Overseas Filipino Bank".
- 5. The bidder or his/her duly authorized representative must be present during the opening of the bids; otherwise, his/her envelope shall not be opened.
- 6. Opening of the Bids will be held on November 17, 2022, 2:00 PM at (LBP) -Manolo Fortich Branch, Sayre National Highway, Barangay Tankulan, Poblacion, Manolo Fortich, Bukidnon.
- 7. Offers not submitted by the bidder or received after the time set for bid opening will not be accepted.
- 8. A bidder may be allowed to withdraw his Bid before the time of opening of bids. Such bid shall be returned unopened. However, after opening of bids has commenced, no bidder shall be allowed to withdraw his offer.

- 9. The Bidder who has the highest bid offer on each of the individual items/lots and which is most advantageous to the government shall be declared the Successful Bidder for that particular item/lot.
- 10. Within seven (7) working days upon receipt of the Notice of Award (NOA) and after paying the full amount, the winning bidder shall haul/pick-up the unserviceable properties. Failure to do so shall constitute a sufficient ground for cancellation of the award.
- 11. The ITB shall be posted in at least three (3) public places in the locality and the OFBank website until November 17, 2022.
- 12. OFBank reserves the right to reject any or all of the bids with or without cause to annul the auction process to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
